21	1. I am charged with two counts of CRUELTY TO ANIMALS, as defined by Section 45-		
22	8-211, MCA. A first conviction is punishable by up to 1 year in jail and/or a fine not to exceed		
23	\$1,000. A second, or subsequent offense is punishable by up to two (2) years in the custody of		
24	the department of corrections and/or a fine not to exceed \$2,500.

1	Additionally, I recognize that I may be required to forfeit any animal affected. I will be

5	my sentence.		
6	2. I have the right to plead not guilty or to persist in that plea if already made.

12	4. By pleading guilty, I give up the right to a trial by judge or jury, the right to have		
13	witnesses testify on my behalf, the right to confront and cross-examine witnesses against me,

11 currently serving.

15 mental defect or impairment or the taking of drugs, alcohol or prescription medicine and I fully

17 12. I am satisfied that my lawyer has been fair to me, has advised me fully of my rights, and18 has represented me properly.

The following facts lead me to believe I am guilty of the above offense: <u>I</u> negligently failed to provide a seriously injured puppy with appropriate medical care.
